Rescissions for the Transportation Alternatives Program Effective July 2017

Rescissions happen when Congress "recalls" funding from the states. These rescissions were included in the final FY2017 appropriations package, with approximately \$850M being rescinded across all transportation programs. The amount rescinded from each state is based on that state's unobligated funds. The state's rescission is then distributed across all programs, including TAP, based on the share of unobligated dollars left in each program compared with the state's overall unobligated transportation dollars.
